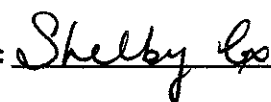

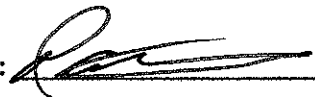

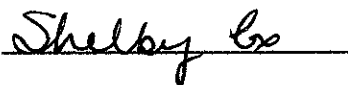

-The town won't be responsible for maintaining the sides of the wharf if damage occurs.

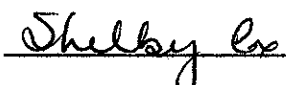
Finance Update:

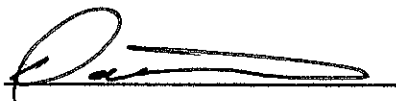
